



## House Rules of our TRAIN & Go areas, the FITNESS GYM, BIOCIRCUIT, outdoors TRAINING TERRACE, Roof terrace, Warm-up and stretching gallery as well as the PRAMA hall

(hereinafter: „House Rules”)

The purpose of the present house rules is to specify the general rules of conduct and requirements for the guests of V.30 Belvárosi Sports Center (hereinafter: V.30 Sports Center) who use its services, in the interest of providing high quality service to the guests, furthermore to provide general information with regards to the intended use of the services to preserve the condition of and to safely operate V.30 Sports Center.

### 1. General information

1.1. By using the services of V.30 Sports Center the guests of V.30 Sports Center expressly accept the present house rules and acknowledge that complying with the House Rules is mandatory at all times and they must use the services of V.30 Sports Center in knowledge of the House Rules. The guests acknowledge that the Operator has the right to inspect compliance with the House Rules at any time, and to make comments or take actions related to compliance. The present House Rules are posted at the site of V.30 Sports Center (H-1054 Budapest, Vadász utca 30.), and are accessible at the [www.v30sportkozpont.hu](http://www.v30sportkozpont.hu) website.

1.2. A V.30 Sports Center is operated by Belváros Lipótváros Sports Center Ltd. (company seat: H-1051 Budapest, Erzsébet tér 4; company registration number 01-09-345052; hereinafter: Operator). You can request information regarding the present House Rules as well as information regarding the operation of V.30 Sports Center, or make suggestions and lodge complaints at the following contacts:

### 1.3. Registration process, rules of entry to the area of V.30 Sports Center

1.3.1. **Registration process:** you can only use the services of V.30 Sports Center after registration, by filling in at least the name, address and email address fields on the so-called Registration Data Sheet. The entry card/watch is for a specific person, it cannot be transferred to another person, the owner of the card is responsible for cheating with the entry card/watch. V.30 Sports Center manages the data provided during the registration confidentially, in accordance with data protection laws and regulations. See further information regarding data management in Section 5 of the House Rules 5.

1.3.2. Rules of entry and exit: you can only enter the Fitness Section of V.30 Sports Center with an entry card/watch for guests with valid tickets or passes purchased at the reception.

### 1.4. Rules of services and their use at V.30 Sports Center

#### 1.4.1. General rules

1.4.1.1. The area of V.30 Sports Center as well as its services may only be used according to their intended purpose and in compliance with the provisions of Belváros-Lipótváros Sports Center Ltd.

the present House Rules. The guests always use the services of V.30 Sports Center exclusively at their own responsibility.

1.4.1.2. The fees for the services of V.30 Sports Center must be prepaid at the time of entry. The passes may only be used during their valid period, the fee for unused occasions cannot be refunded or used after the valid period. Our extendable annual pass is an exception. Please, indicate your intent for extension in advance at the [szuneteltetes@v30.hu](mailto:szuneteltetes@v30.hu) email address. The operator reserves the right to make changes.

1.4.2. We have a free safe for valuables and phone storage for our guests at the reception, depending on capacity, which you can request when you buy your ticket. We can only accept objects that fit in a safe. For security reasons we cannot accept luggage, bags, backpacks and laptops for safeguarding. Providing a deposit is mandatory.

1.4.3. V.30 Sports Center does not take responsibility for lost, stolen items and instruments.

1.4.3.1. The guests have the right to use the sports equipment in the area of V.30 Sports Center according to their intended purpose (e.g. weights, kettlebell, boxing bags, stepper, ball, skipping rope, rubber carper, etc.). The guests must return the sports equipment used by them to the proper place, or if they received it at the reception, to return it there upon leaving. The guests have financial responsibility toward the Operator if the equipment are damaged or lost.

## 2. Rules and prohibitions

### IT IS PROHIBITED!

- To throw away trash in the locker rooms, on the corridors and in the showers;
- To bring food or eat in the locker rooms and in the area of the gyms;
- To bring alcohol, drugs and illegal performance enhancing substances or consume them in the locker rooms and in the area of the gyms;
- To bring vegetables, fruits and other foods into the gym;
- To obstruct the stairs and walkways of the gym and locker rooms;
- To enter the gym in street shoes;
- To bring fragile objects or objects that may cause injury to the gym;
- To remain in the gym after closing by unauthorized persons or off-duty gym staff without permission.

2.1. Persons with limited legal capacity, under the influence of alcohol or drugs, and those who are suffering from contagious disease are not allowed in the V.30 Sports Center. Pregnant women use the services of V.30 Sports Center exclusively at their own responsibility.

2.2. Dogs and other pets are not allowed in the area of V.30 Sports Center.

2.3. Consuming alcohol is prohibited in the entire area of V.30 Sports Center (except in the area of the snack bar), and smoking is also prohibited.

- 2.4. It is prohibited to bring into the area of V.30 Sports Center any hazardous materials (contagious, poisonous, flammable, explosive, acidic, irritating or materials causing otherwise harmful powders, gases, steam, fog or radiation), weapons, stabbing or cutting instruments or any other object, drug, intoxicating substance that is considered dangerous by the Operator and alcohol.
- 2.5. Any decoration or promotional material (e.g. plant, leaflets, advertisements, promotional material), electronic devices, toys, etc. may only be placed in the area of V.30 Sports Center exclusively with the prior approval of the Operator.
- Aggressive, rude behavior that endangers the health of others, pushing, fighting or threatening, behavior that disturbs the training of other guests, or that which disrupts public morals, public order and the relaxation of others is prohibited. In the case of such behavior we call the police immediately.
- 2.6. It is prohibited to bring rollers and bicycles into the area of V.30 Sports Center. Storage is provided by the bicycle storage of V.30 Sports Center.
- 2.7. All guests are required to use the services of V.30 Sports Center according to their intended purpose, in a way not to disturb the others in their training. Everyone is required to keep the area of the V.30 Sports Center tidy and clean. V.30 Sports Center has the right to ban those who violate the House Rules from using the services of V.30 Sports Center, or if that is necessary to remove them from the area of V.30 Sports Center or have them removed. Persons who have been removed from the area of V.30 Sports Center or banned from using its services may not bring any claims against the Operator.
- 2.8. The services of V.30 Sports Center may only be used in attire required by the premises of V.30 Sports Center.
- 2.9. At the Train & GO Fitness gym only the sports equipment of V.30 Sports Center may be used, it is prohibited to bring in any other sports equipment, or fragile (e.g. glass) or sharp objects. Drinks (nonalcoholic drinks, e.g. water, soft drinks) may only be carried in plastic bottles.
- 2.10. Fittings and equipment in the bathrooms and toilets may only be used for their intended purpose, it is forbidden to throw or place rubbish, rags, tampons, hazardous substances in the drain, toilet.
- 2.11. Commercial activities, barter, currency exchange, sales, advertising, propaganda (placement of billboards, stop signs, wall stickers and leaflets), distribution of souvenirs and product samples promoting commercial activities, sale of consumer goods for any commercial purpose, insurance brokerage or securities trading are prohibited in the V.30 Sports Center. Gambling or playing music from an external sound system is also prohibited. Any promotional activity throughout the V.30 Sports Center may only be carried out with the prior approval of the V.30 Sports Center. It is forbidden to make audio or video recordings in the V.30 Sports Center or during the sessions without the prior approval of the Operator.
- 2.12. Only the personal trainers, coaches and instructors of the V.30 Sports Center may conduct personal training or hold classes throughout the V.30 Sports Center, and third parties are not entitled to perform such activities.
- 2.13. All guests are obliged to hand over any found objects at the reception of the V.30 Sports Center.

2.14. The Operator of the V.30 Sports Center reserves the right to hold a private event in the V.30 Sports Center and at the same time exclude guests from the V.30 Sports Center. In this case, the V.30 Sports Center will notify the guests in advance on its website and extend the valid season ticket by one day.

### **3. The V.30 Use of Sports Center facilities**

3.1. Use of the changing room: The V.30 Sports Center provides male and female clients with separate shower and a locker room, the prices of which are included in the price of tickets and passes.

#### **3.2. Use of Fitness Room with Outdoor Fitness Terrace and Roof Terrace and Warm-up and Stretching Gallery**

3.2.1. Fitness equipment and machines may only be used for their intended purpose and in accordance with the instructions.

3.2.2. Guests can use the fitness equipment and machines at their own risk. When using the machines and equipment, the guest's own health, fitness, shape and endurance must be taken into account. If you have any questions, please contact your V.30 Sports Center colleague for help or guidance. The guideline is not the same as a personal training, which is a separately priced service. Only those who have purchased a personal training ticket or pass in addition to their ticket or pass are entitled to attend personal training. The personal training time is 50 minutes, it can only be redeemed at the V.30 central reception.

3.2.3. Children under the age of 14 are not allowed on the Train & Go premises. Between the ages of 14 and 16 you can only use it under the supervision of a parent-licensed trainer, and between the ages of 16 and 18 you can stay in the fitness room with a parental license.

3.2.4. The Fitness Room can only be used in sportswear (sports shoes, T-shirt, top, sports trousers) that is hygienically suitable, clean and suitable for the use of sports equipment.

3.2.5. Street clothing, street shoes, muddy or dirty sports shoes should not be worn.

3.2.6. You can only train in closed sports shoes, slippers, sandals, socks, stockings or barefoot.

3.2.7. Towels are mandatory in the Train & Go areas. In the event of incomplete or inappropriate sportswear, a colleague of the V.30 Sports Center has the right to require the guest to wear the appropriate clothing, and in case of unsuccessful request, to prohibit the use of the Fitness Room.

3.2.8. It can be used without disturbing other guests or making noise.

3.2.9. After using the fitness equipment and machines, the equipment must be put back in place and the machines must be reset / reset.

3.2.10. Improper use of fitness equipment and machines can result in accidents, and colleagues at the V.30 Sports Center will be happy to assist guests with any questions.

3.2.11. Improper use of fitness equipment and machines, dropping and throwing machines and weights is strictly forbidden. It is also forbidden to certify any behavior that is dangerous to oneself or others. Please note that only personal trainers, coaches or instructors of the V.30 Sports Center may conduct personal training or education throughout the V.30 Sports Center, and third parties are not entitled to perform such activities.

3.2.12. Only staff at the V.30 Sports Center can enter the counter in the Fitness Room. It is forbidden to take a product or device from the counter.

3.2.13. The TANITA body composition measuring device in the fitness room can only be used under the supervision of V.30 Sports Center staff. Tanita body composition measurement is a paid service, it can be purchased at the reception.

3.2.14. Only guests with a Train & Go ticket or pass can stay on the outdoor gym on the roof terrace and in the Warm-up and Stretching Gallery.

3.2.15. All our guests stay on the outdoor training terrace and on the roof terrace and in the Warm-up and Stretching Gallery at their own risk and use the fitness equipment.

3.2.16. Only equipment approved by the V.30 Sports Center coaches may be used on the roof terrace and outdoor training terrace, and only they may take the equipment out.

3.2.17. The use or storage of any device on glass surfaces is strictly prohibited.

#### **4. Use of the Prama rooms:**

4.1. The Prama halls (hereinafter: Gym) can only be used in sportswear (sports shoes, T-shirt, top, sports trousers) that is hygienically suitable, clean and suitable for the use of sports equipment.

4.2. Street clothing, street shoes, muddy or dirty sports shoes are not allowed in the Prama Hall. If you have any questions about the right attire, V.30 Sports Center colleagues will be happy to assist you. In the event of incomplete or inappropriate sportswear, a colleague of the V.30 Sports Center is entitled to require the guest to wear the appropriate clothing, and in the event of an unsuccessful request, to prohibit the use of the Gym.

4.3. Children under the age of 18 can only use the Prama Room with parental permission and the supervision of a coach.

4.4. The Gym can only be used during classes, under the guidance and supervision of an instructor. The guest is obliged to keep the ticket received at check-in during the hour and present it for inspection if necessary.

4.5. All guests are allowed to attend the classes at their own risk and in good health.

4.6. Classes are not open to guests who are drunk or intoxicated, have an infectious disease, are sick, or have a fever.

4.7. It is recommended that pregnant women seek the instructor's opinion regarding participation in the class, however, the pregnant woman may in all cases participate in the classes only at his / her own discretion and responsibility.

4.8. The capacity of the Prama room is maximized depending on the size of the room and the type of lessons. The location in the room is on a first-come, first-served basis, and guests arriving later can check in at the available time gaps. If there is not enough space in the room or the instructor considers that the late arriving guest cannot join the course because it would disturb the course of the class or is not recommended for the guest from a health point of view, the guest will not attend the given class, but may join the next class.

If you are late more than 15 minutes the trainer is entitled to refuse you joining the class.

#### **5. Data handling:**

5.1. The Operator Belváros Lipótváros Sport Center Ltd. (Registered office: 1051 Budapest, Erzsébet tér 4. company registration number: 01-09-345052; hereinafter: Data Controller) handles the personal data and image provided by the guest in accordance with the provisions of Act CXII of 2011 on information self-determination and freedom of information for two years or until a request for deletion was handed in, or until the guest gave permission for the data to be stored

for, handles the data for free and for the purpose of its own marketing and direct marketing activities. Upon expiration of the data management period or within 30 days after receipt of the request for deletion of the data, the Data Controller shall delete the personal data from the register. Upon request, the Data Controller shall provide information on the handling of the data, and the guest may request their correction or deletion at the following addresses: Belváros Lipótváros Sport Center Ltd. (Registered office: 1051 Budapest, Erzsébet tér 4.) by post, or electronically at the following address: [adatvedelem@hu](mailto:adatvedelem@hu). The guest has the right to protest against the processing of his / her personal data. If you do not agree with the data controller's decision based on your protest, you can apply to a court or the Hungarian National Authority for Data Protection and Freedom of Information. The data management has been reported to the Hungarian National Authority for Data Protection and Freedom of Information, the registration number of the data management is being issued. For more details on data management please see the data protection policy of Belváros-Lipótváros Sport Center Ltd.

- 5.2. By using the services of the V.30 Sport Center or accepting these Rules, the guest gives his / her express consent free of charge, ie without any remuneration request or fee claim, to the Operator Belváros Lipótváros Sport Center Ltd. (or its affiliates, subcontractor, etc.) in order to present or promote the services, activities of the V.30 Sports Sport Center Ltd. exclusively in publications, posters and on the Internet printed for the above purpose - in particular, but not exclusively on the official website of the V.30 Sport Center, the official Facebook community page of the V.30 Sport Center and the official Instagram community page of the V.30 Sport Center - to publish, distribute and reproduce it in Hungary in any number of copies and at any time, without any time limit, as well as in internal company materials and as reference material in specialized publications and materials, trade fairs and exhibitions related to its activities. The right of reproduction includes the right to copy the Recordings or posters or other material made using them on images, as well as the right to copy them on a computer or electronic data carrier.
- 5.3. Taking this into account, the guest using the services of the V.30 Sport Center in connection with the above appearances and uses may not charge any fees, costs to Belváros Lipótváros Sport Center Ltd., its affiliates, subcontractors and other third parties, or ask for royalties. You may not make any claims. The Operator Belváros Lipótváros Sport Center Ltd. will notify its guests in advance about the date of making Recordings.

## 6. Actions to be taken in the event of an emergency, fire alarm or bomb alarm

6.1. Fire alarm or bomb alarm: In the event of a fire alarm or bomb alarm, sports activities, wellness or other services must be stopped immediately and the premises must be evacuated. In an emergency, the elevators do not work. To leave, use the nearest staircase and exit, leaving the building on the escape route marked with directional lights. It is only possible to return to the building after the emergency is over, with the permission of the security staff.





6.2. Extraordinary event, accident: An extraordinary event is any event or circumstance significantly different from the average that endangers the life and physical integrity of the persons in the V.30 Sports Center, or leads to serious consequences for the material assets in the V.30 Sports Center, or it threatens to cause a serious disturbance in the operation of the V.30 Sports Center. The following in particular are considered to be extraordinary events:

6.2.1. fire, explosion;

6.2.2. threat of explosion;

6.2.3. an offense committed or attempted by or against employees or guests of the V.30 Sports Center;

6.2.4. violent behaviour or attempt at the V.30 Sports Center, or against its equipment or facilities;

6.2.5. accidents resulting in death or serious injury;

6.2.6. power outages;

6.2.7. elemental damage.

6.3. If an extraordinary event is detected, the receptionist colleague or the competent authorities must be notified immediately calling the following telephone numbers:

6.3.1. Ambulances: 104

6.3.2. Fire Department: 105

6.3.3. Police: 107

6.3.4. General emergency number: 112

6.4. If our guests notice an incident or accident that has occurred in the area of the V.30 Sports Center, they must immediately notify the receptionist on duty, in order to take appropriate action, of which the Operator will keep a report.
